


## **Inflation Update**

## Consumer inflation touched lowest level since Dec 2021 in Mar 2023


- Consumer Price Index based inflation (CPI) slowed to 5.66% in Feb 2023 from 6.44% in the previous month and 6.95% in Mar 2022 due to easing of food inflation. Inflation rate fell to its lowest level since Dec 2021.
- Retail inflation went below the upper tolerance level of the Reserve Bank of India's retail inflation target of 6% during the reported period. Nonetheless, in the last 15 months, inflation remained above the upper tolerance band for 12 months.
- The Consumer Food Price Index increased at a slower pace to 4.79% in Mar 2023 as compared to 5.95% rise in Feb 2023 and 7.68% in the same month of the previous year.
- Inflation for food and beverages also slowed to 5.11% during the reported period from 6.26% in Feb 2023 and 7.47% in the same month of the previous year.
- Under food and beverages, retail inflation slowed on yearly basis majorly due to vegetables and oils and fats, which contracted 8.51% and 7.86% compared with a rise of 11.64% and 18.73%, respectively, during the corresponding period of last year. However, inflation for spices and cereals & products surged to 18.21% and 15.27% in Mar 2023 from 8.50% and 5.00% increase, respectively in Mar 2022.
- Inflation for clothing and footwear eased marginally to 8.18% in Mar 2023 from 9.40% in the same month of the previous year. However, inflation for fuel and light accelerated to 8.91% in Mar 2023 from 7.52% in the same month of the previous year.
- Inflation for the 'miscellaneous' group, which accounts for 28.32% of the CPI and includes services, slowed to 5.77% in Mar 2023 from 6.12% in the previous month and 7.02% in Mar 2022.
- Among states, the highest inflation rate of 7.63% was recorded by Telangana, followed by Haryana and Punjab for which inflation stood at 6.92% and 6.84%, respectively. On the other hand, the lowest inflation rate of 1.88% was seen in Chhattisgarh.
