


Inflation Update

Consumer Price Index based inflation touched eleven month low in November


- Government data showed that Consumer Price Index based inflation slowed for the second consecutive month and touched eleven-month low to 5.88% in Nov 2022 from 6.77% in the previous month but accelerated from 4.91% in Nov 2021.
- Retail inflation fell below the upper tolerance level of the Reserve Bank of India's retail inflation target of 6% for the first time in eleven months.
- The Consumer Food Price Index increased at a slower pace to 4.67% in Nov 2022 as compared to 7.01% rise in Oct 2022 but accelerated from 1.87% in the same month of the previous year.
- Inflation for food and beverages slowed to 5.07% in Nov 2022 from 7.10% in the previous month but faster than 2.60% in the same month of the previous year.
- Under food and beverages, retail inflation pushed up on yearly basis majorly due to cereals and products and spices which grew 12.96% and 19.52% respectively. However, inflation for vegetables, oils and fats and sugar and confectionery contracted 8.08%, 0.63% and 0.25% respectively in Nov 2022.
- Inflation for clothing and footwear went up to 9.83% in Nov 2022 from 7.94% in the same month of the previous year. Inflation for fuel and light accelerated to 10.62% in Nov 2022 from 9.93% in the previous month but eased from 13.35% in the same month of the previous year.
- Inflation for the 'miscellaneous' group, which accounts for 28.32% of the CPI and includes services, rose to 6.07% in Nov 2022 from 5.90% in the previous month but came down from 6.75% in Nov 2021.
- Among states, the highest inflation rate of 7.89% was recorded by Telangana, followed by Andhra Pradesh and Haryana for which inflation stood at 6.90% and 6.81%, respectively. On the other hand, the lowest inflation rate of 2.17% was seen in Delhi.
