Inflation Update


Consumer Price Index based inflation eased to 6.77% in October

- Government data showed that Consumer Price Index based inflation slowed to 6.77% in Oct 2022 from 7.41% in the previous month but accelerated from 4.48% in Oct 2021.
- Retail inflation thus stayed above the upper tolerance level of the Reserve Bank of India's retail inflation target of 6% for the tenth consecutive month.
- The Consumer Food Price Index increased at a slower pace to 7.01% in Oct 2022 from 8.60% in the previous month but accelerated from 0.85% in the same month of the previous year.
- Inflation for food and beverages slowed to 7.04% in Oct 2022 from 8.41% in the previous month but faster than 1.82% in the same month of the previous year.
- Under food and beverages, retail inflation pushed up majorly due to Cereals and products, Milk and products and vegetables, which jumped to 12.08%, 7.69% and 7.77% in Oct 2022 from 0.41%, 3.19% and -19.43% in Oct 2021, respectively. However, inflation for oils and fats contracted to 2.15% in Oct 2022 from rise of 33.57% in Oct 2021.
- Inflation for clothing and footwear went up to 10.16% in Oct 2022 from 7.53% in the same month of the previous year. Inflation for clothing and footwear has gone up consistently during sixteen out of eighteen months.
- Inflation for fuel and light eased to 9.93% in Oct 2022 from 10.39% in the previous month and 14.35% in the same month of the previous year.
- Inflation for the 'miscellaneous' group, which accounts for 28.32% of the CPI and includes services, eased to 5.90% in Oct 2022 from 6.06% in the previous month and 6.83% in Oct 2021.
- Among states, the highest inflation rate of 8.82% was recorded by Telangana, followed by Andhra Pradesh and Haryana for which inflation stood at 7.93% and 7.79%, respectively. On the other hand, the lowest inflation rate of 2.99% was seen in Delhi.







Growth in Inflation Components
