
## Inflation Update

#### Consumer Price Index based inflation accelarated to 7.41% in September


- Government data showed that Consumer Price Index based inflation accelerated to 7.41% in Sep 2022 from 7.00% in the previous month and 4.35% in Sep 2021. Inflation reached its highest level in five months during the latest period.
- Retail inflation thus stayed above the upper tolerance level of the Reserve Bank of India's retail inflation target of 6% for the ninth consecutive month.
- The Consumer Food Price Index also rose at a faster pace to 8.60% in Sep 2022 from 7.62% in the previous month and 0.68% in the same month of the previous year.
- Inflation for food and beverages rose faster to 8.41% in Sep 2022 from 7.57% in the previous month and 1.61% in the same month of the previous year.
- Under food and beverages, retail inflation pushed up majorly due to vegetables, and spices, which jumped to 18.05% and 16.88% in Sep 2022 from -22.42% and 4.84% in Sep 2021, respectively. However, inflation for oils and fats eased significantly to 0.37% in Sep 2022 from 34.19% in Sep 2021.
- Inflation for clothing and footwear went up to 10.17% in Sep 2022 from 9.91% in the previous month and 7.22% in the same month of the previous year. Inflation for clothing and footwear has gone up consistently during sixteen out of seventeen months.
- Inflation for fuel and light eased to 10.39% in Sep 2022 from 10.78% in the previous month and 13.63% in the same month of the previous year.
- Inflation for the 'miscellaneous' group, which accounts for 28.32% of the CPI and includes services, slowed to 6.06% in Sep 2022 from 6.38% in Sep 2021.
- Among states, the highest inflation rate of 9.44% was recorded by West Bengal, followed by Telangana and Madhya Pradesh for which inflation stood at 8.67% and 8.65% respectively. On the other hand, the lowest inflation rate of 4.03% was seen in Delhi.




